Capacity is limited to 20 participants. The program integrates KKC's checkup with 9 hours' 9h sleep checkup in a single flow, aiming to translate pre-disease insights into concrete lifestyle actions.

KKC, a preventive-medicine organization that provides mobile and facility-based health screenings as well as health promotion, counseling, guidance, support, and research, will conduct the medical checkups and provide online health counseling for this program. Sumitomo Riko will provide its non-wearable MONILIFE™ wellness pressure sensor, installed in 9 hours capsule units, enabling low-burden data acquisition under near-everyday conditions. 9 hours will provide the accommodation environment (capsule hotel) and visualize the sleep data obtained through the 9h sleep checkup, which will be shared with KKC.

# About Health Checkup & Sleep Analysis Package

This package combines KKC's health checkup and web-based counseling with 9 hours' 9h sleep checkup. Sleep is closely linked to physical and mental health, and insufficient or poor-quality sleep has been associated with increased risks of lifestyle-related diseases. From a preventive, pre-disease perspective, the program analyzes sleep alongside the health checkup to help identify risks earlier.

Participants receive a health checkup at KKC Wellness Tokyo Nihonbashi Health Checkup Clinic to detect lifestyle-disease risks, then stay that night at a 9 hours Casouke hotel to undergo the 9h sleep checkup. About three weeks later, a KKC public health nurse provides an online consultation that integrates the checkup and sleep analysis results with practical advice for improving daily habits.

During the 9h sleep checkup, participants do not wear any devices. Sleep quality and respiratory status are estimated using equipment installed in the capsule bed, including Sumitomo Riko's MoniLife™ Wellness, enabling early identification of sleep-related issues with minimal burden.

By combining a health checkup, which clarifies health status and enables early detection of risks, with objective sleep analysis, participants gain a comprehensive view of their condition and an opportunity to review and improve lifestyle habits.
