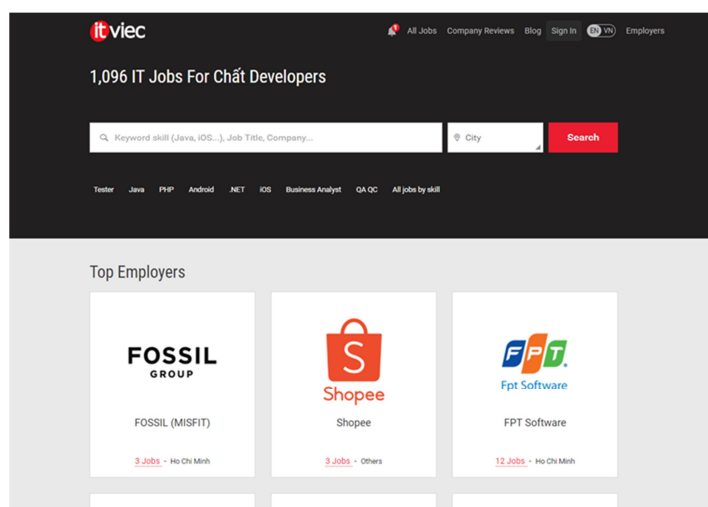


## Mynavi has Acquired ITVIEC, operator of leading job search website for IT engineers in Vietnam
