Establishment of DeCurret Holdings, Inc. and Transition to Holding Company Structure


DeCurret Inc. (HQ: Chiyoda-ward, Tokyo Japan, President & CEO: Kazuhiro Tokita, hereinafter "DeCurret") is pleased to announce that DeCurret Inc. has established DeCurret Holdings, Inc. on December 27, 2021 through a share transfer, and that the company became its wholly owned subsidiary and shift to a holding company structure.

In addition, on February 1, 2022, the digital currency business will be transferred from the company to DeCurret DCP, Inc. through an absorption-type split.

[Background]

In the cryptoasset business and digital currency business, DeCurret has been operating its business strategically and flexibly in response to the environment and circumstances, while appropriately responding to various regulations. In the future, DeCurret believes that it will be possible to diversify its business by establishing new sibling companies in new fields, and DeCurret has decided to review our business organization structure with the aim of promoting each business efficiently.
