



GREEN × EXPO 2027 Signs Official Participation Contract with the International Tropical Timber Organization (ITTO)

- Tropical Forests to be prominent at GREEN × EXPO 2027 as ITTO becomes the first international organization to sign an Official Participation Contract -

On 12 March 2026, GREEN×EXPO Association (Official Name: Japan Association for the International Horticultural Expo 2027, Yokohama) entered an official participation contract for GREEN×EXPO 2027 (International Horticultural Expo 2027, Yokohama, Japan) with the International Tropical Timber Organization (ITTO). This marks the first official participation contract signed with an international organization.

ITTO is an intergovernmental organization promoting the sustainable management of the world's tropical forests and the expansion and diversification of international trade in tropical wood and wood products from legally harvested and sustainably managed forests. Celebrating its 40th anniversary this year, ITTO is headquartered in the City of Yokohama since its inception in 1986. As the only international organization headquartered in Yokohama, ITTO is a proud contributor to events, activities, and engagement with its host Yokohama City, the local community and wider Japanese public.

In collaboration with Yokohama City, ITTO will contribute to energizing GREEN×EXPO 2027 through a wide range of initiatives. These include an exhibition themed “coexistence between tropical forests and humanity” featuring a simulated tropical forest environment as well as events and workshops that will educate and inspire the public, especially young people.

■ Official Participants / Commissioner of Section

Official Participants are those foreign governments and international organizations that have accepted an official invitation from the Government of Japan to participate in the Expo. Each Official Participants in the Expo will be represented by a Commissioner of Section.

■ Commissioner of the Expo

The Commissioner of the Expo is the position appointed by the Government of Japan under the Temporary Measures Act and represents the Government of Japan with respect to GREEN×EXPO 2027.

■ International Tropical Timber Organization (ITTO)

The International Tropical Timber Organization (ITTO) is an intergovernmental organization promoting the sustainable management and conservation of tropical forests and the expansion and diversification of international trade in tropical timber from sustainably managed and legally harvested forests.

ITTO was established in 1986 under the 1983 International Tropical Timber Agreement (which came into force in 1985). Since its inception, it has been headquartered in the City of Yokohama. ITTO celebrates its 40th anniversary this year. The ITTO is governed by the International Tropical Timber Agreement, 2006 and has 76 member countries: 37 producer countries, 39 consumer countries including the European Union. ITTO has implemented over 1,400 policy and capacity development projects to date, focusing amongst others on human resource development and institutional strengthening related to sustainable forest management, forest restoration, forest fire prevention, and building legal and sustainable tropical timber supply chains. It plays a significant role in the conservation of tropical forests in the Asia-Pacific, Latin America, and Africa.

For 40 years since its establishment, the ITTO in Japan has focused on collaboration with the local community, contributing to the development of the next generation through many initiatives such as joint classes with schools in Yokohama. In 2024, ITTO, the City of Yokohama Green Environment Bureau, and the Yokohama Greenery Foundation signed a “Agreement on Awareness-Raising Activities Concerning the Conservation and Sustainable Use of Tropical Forests and Biodiversity.” This agreement facilitates public relations and awareness-raising activities in collaboration with the city's zoos.

ITTO's Activity Plan for GREEN×EXPO 2027

- **Exhibition** (Themed “Coexistence between tropical forests and humanity”, featuring displays simulating lush tropical environments)
- **International Conference** (A forum for sharing knowledge and perspectives on environmental, social and developmental issues surrounding tropical forests, including young people)
- **Workshop** (Workshops aimed at deepening understanding of tropical forests)
- **Tropical forests' contributions to Nature-based Solutions**
